Purpose of Agreement

The purpose of this agreement is to:

- Establish a **single unified election process (2026)** for the term 2026–2028
- Ensure a **smooth, respectful, and transparent transition** to the newly elected executive committee
- Promote **unity, trust, and harmony** within the community

Binding Nature of Agreement

2.1 This document represents the **full and final mutual understanding** between both parties regarding the unified election.

2.2 Once signed:

- Both parties agree to uphold the terms in good faith
- No separate or parallel election processes shall be conducted
- This agreement supersedes prior informal arrangements

Agreed Terms

Membership and Voting Rights

- Membership from both parties shall be **collated and consolidated** into one verified list
- Final voter list will be published according to the election program and constitution
- The **Election Committee** will:
 - Seek membership data from both groups
 - Verify membership where required
 - Publish the official voter list

Authority to Sign

- Two members from each party will sign on behalf of their team
- Each signatory confirms they have **full consent and authority** from their respective groups

AGM Presentation

- The AGM will be held in accordance with the constitution on the same day as polling
- **Dr. Roshan Khadka**, as President, will chair the AGM
- Each party will present their activities, contributions, and reports

The committee's sole responsibility is to conduct a **fair and constitutional election** for 2026–2028.

Transfer of NZNS Assets

Will be **fully transferred** to the newly elected executive:

- On the day of results announcement, or
- Within one week of results announcement

Conduct and Behaviour

Both parties agree to:

- Maintain **respectful communication** at all times
- Avoid public disputes, criticism, or escalation
- Support a **peaceful and unified transition**

- The efforts of both groups
- The shared commitment and **selfless intent to unite the community**
